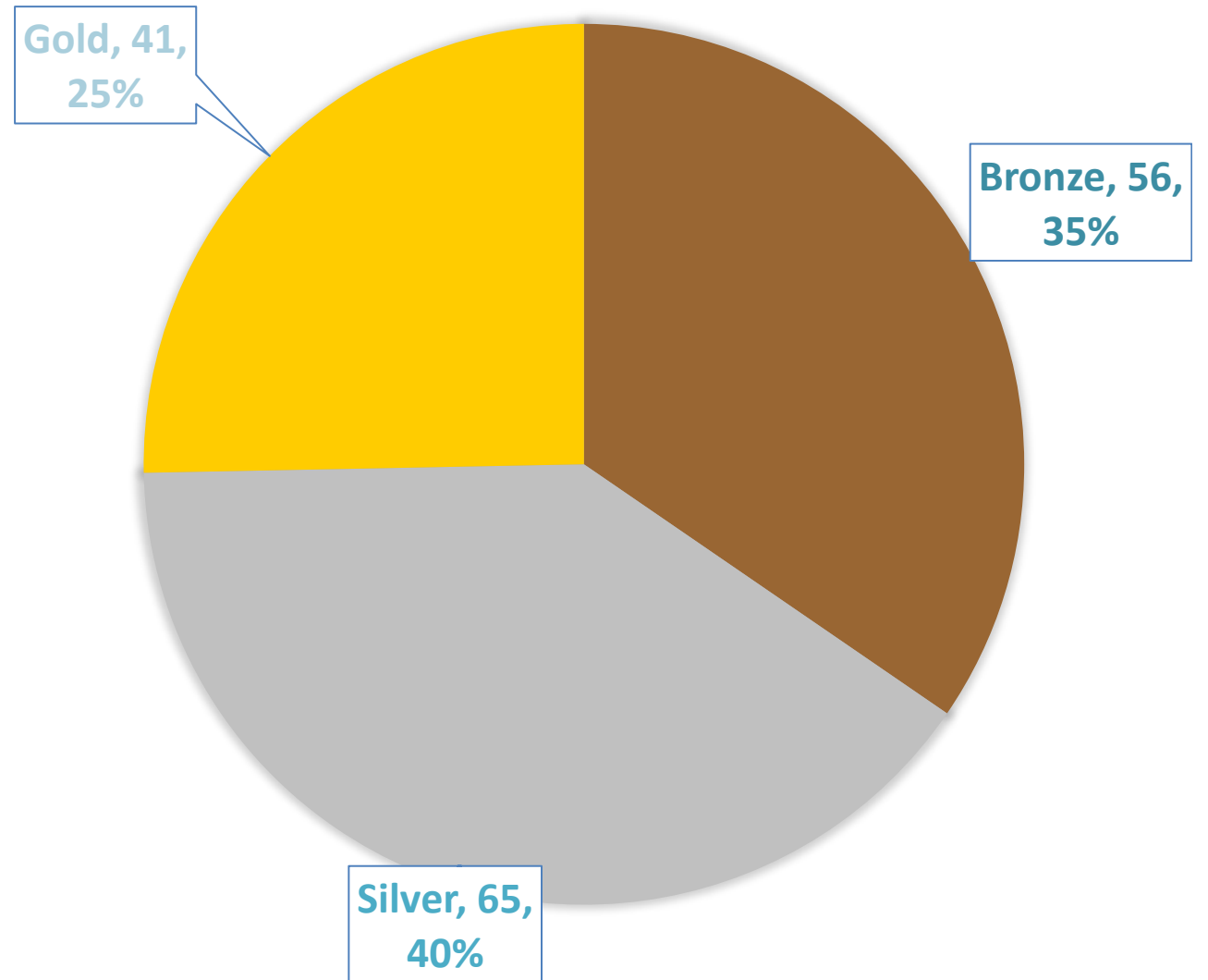

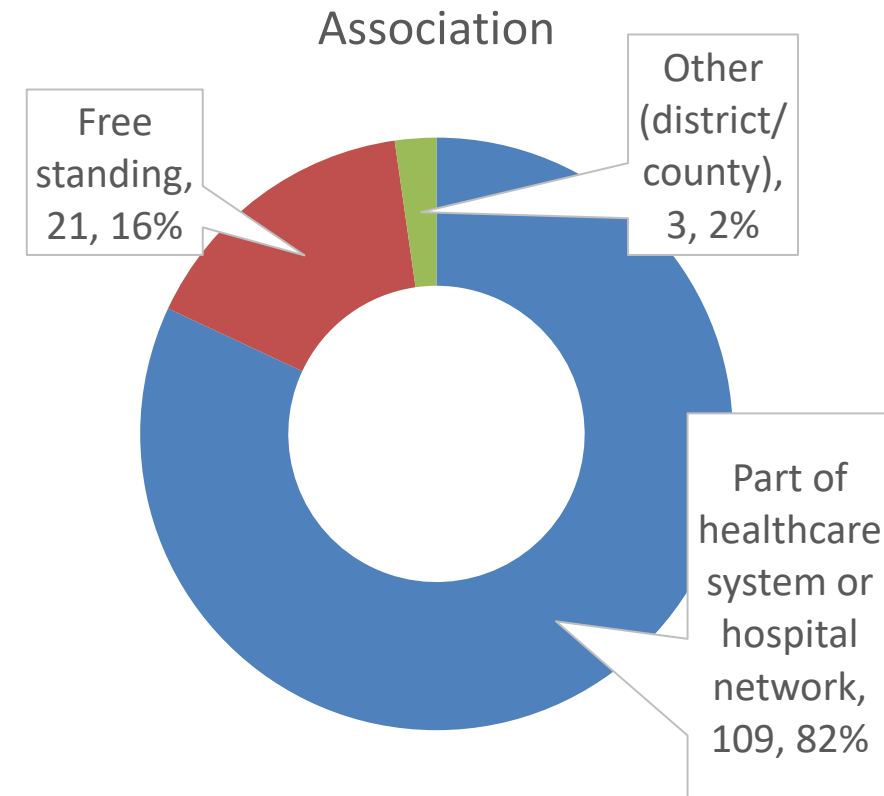

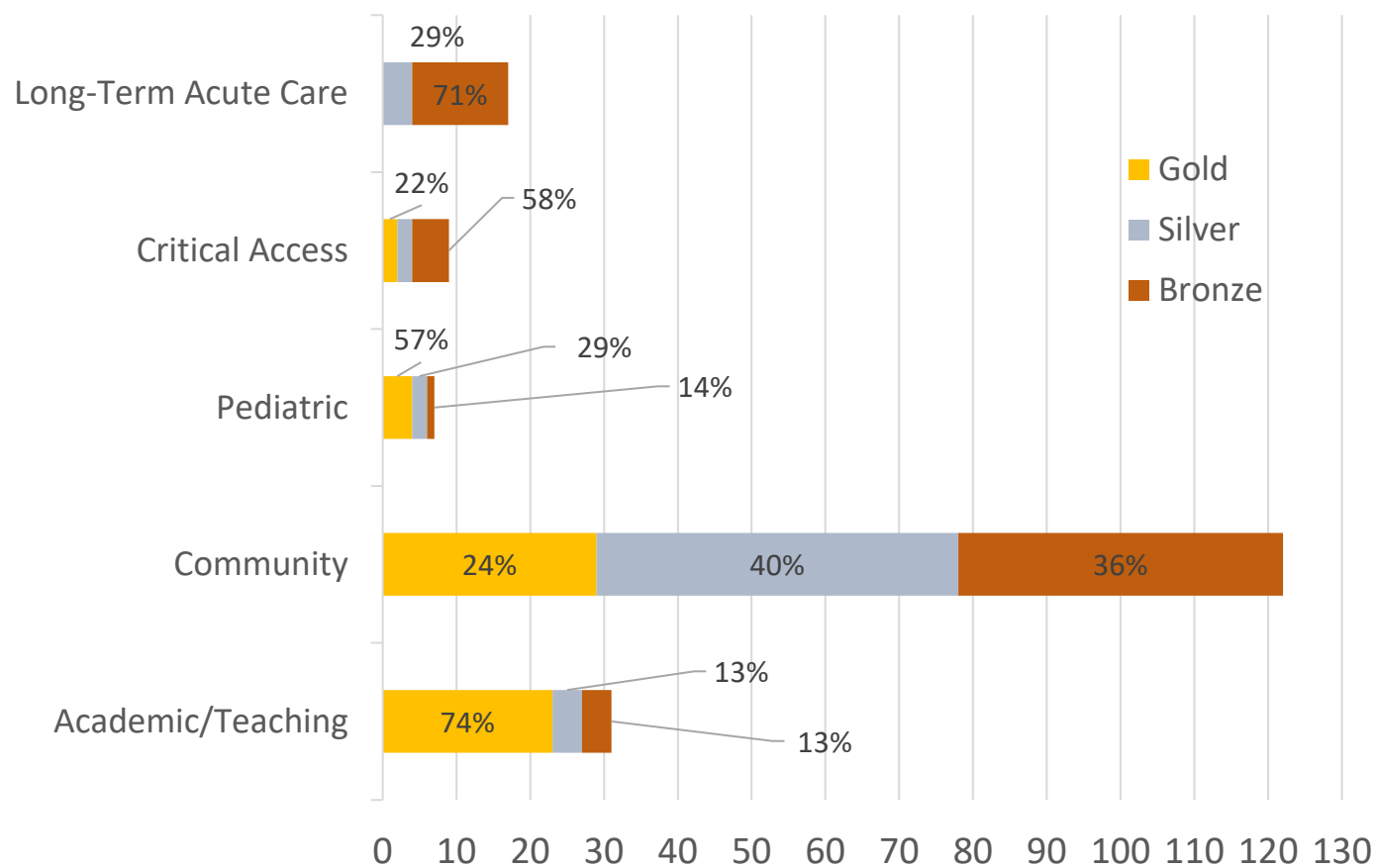

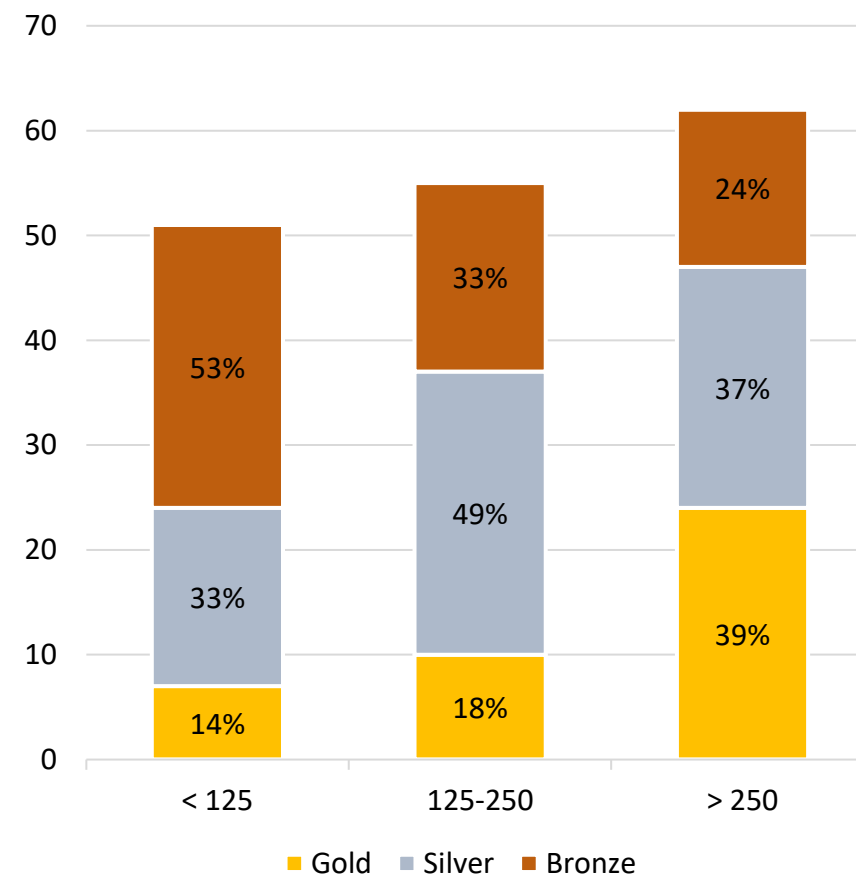
Demographics: Facility Region and Association



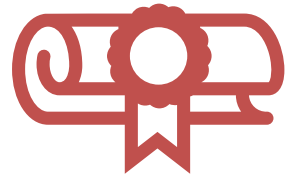
Hospitals Enrolled by Type and Bed Number

Individual institutions within a healthcare system will need to apply separately to obtain designation for each facility.**

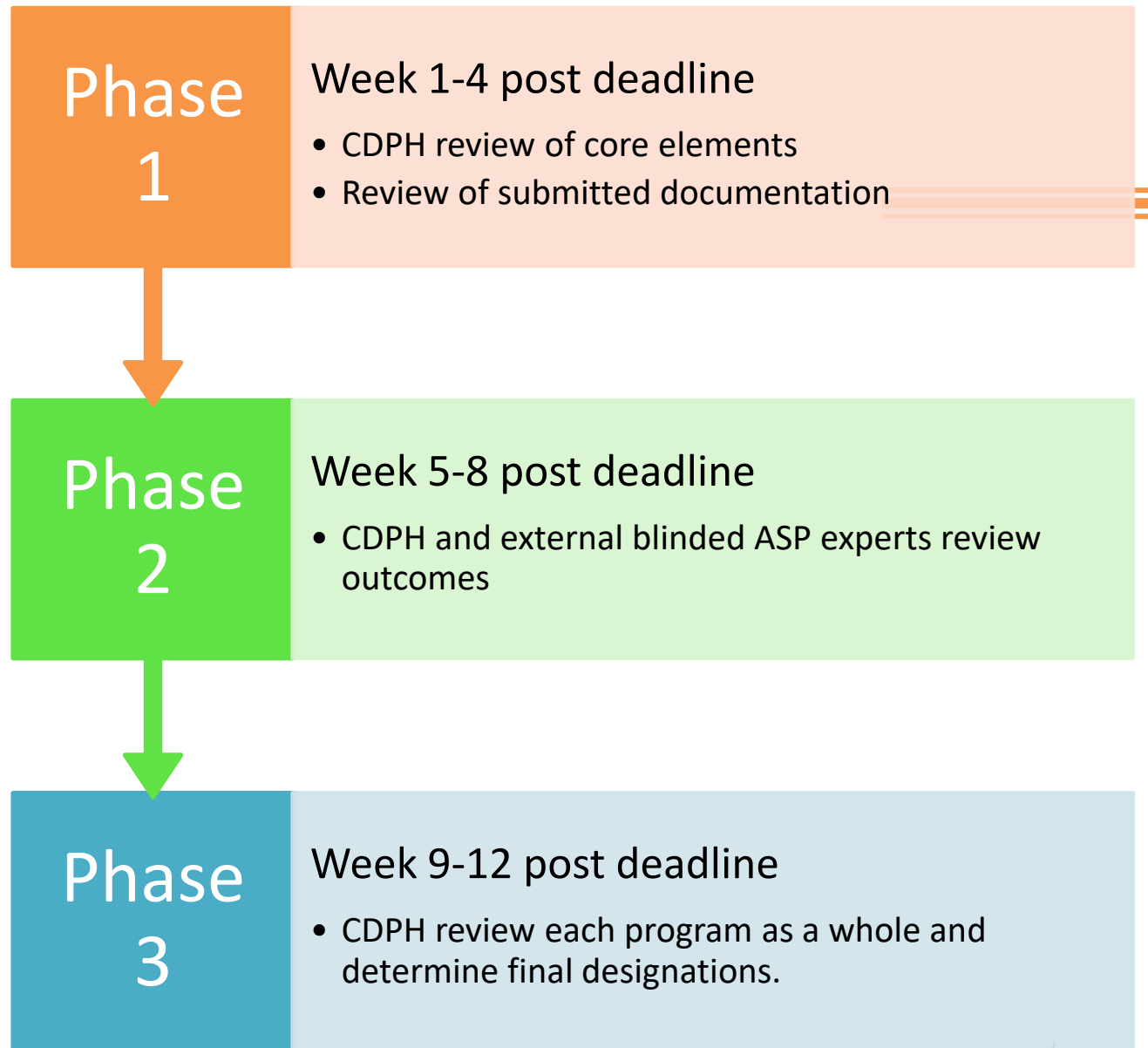
Currently, we are accepting applications from hospital ASP only; we will expand the program to include skilled nursing facilities (SNF) in the future. All hospitals are encouraged to apply. Facilities who wish to apply but do not meet Honor Roll criteria may still complete the application and use resources offered through the ASP Honor Roll program.
